| Volltext | Card driving licences issued from 19.01.2013 onwards are limited to 15 years. If the validity of the driving licence has expired, a new driving licence must be applied for, unless you renounce the driving licence. |
| | A driving licence issued before 19.01.2013 must be exchanged for a current driving licence model by the date resulting from the following information, if you do not renounce your driving licence: |
| | Driving licences issued up to and including 31 |
