	subjective right in rem is also required for the deletion of the right or for the registration of the change of content or rank of this right, § 21 GBO, because subjective-real rights are considered part of the dominant property according to § 96 BGB.
Erforderliche Unterlagen	Application with description of the right, the indication of the dominant property and the serving property
Voraussetzungen	• Application of the owner of the dominant land or any person whose consent is required under the Civil Code to revoke the right The right must be registered on the serving property before or at the same time. You can have the note entered in the land register of the dominant property in the case of the following property ownership rights: • Easement according to the Civil Code • Subjective-real right of first refusal according to the Civil Code • Subjective-real real burden according to the Civil Code • Ground rent according to the Heritable Building Rights Act • Superstructure pension according to the Civil Code • Emergency route pension in accordance with the Civil Code The right must be registered on the serving property before or at the same time
