Teaser	As the operator of a care facility, you can calculate operational investment costs separately. If you have not received any funding, you only have to inform us of the planned amount of these costs.
Volltext	<p>As the operator of a care facility, you can calculate operationally necessary investment costs (e.g. rental or loan costs for buildings, costs for durable goods) separately, as these may not be included in the costs for care allowances, accommodation or meals.</p> <p>You inform the competent state authority of the amount of these planned costs (even before any change).</p> <p>This procedure only applies if you have not received any funding for the investment costs under state law – otherwise please use the application for funded institutions, which can be found e.g. via the website of the RP Gießen</p> <p>In the course of the application, you also have the option of specifying different cost rates (e.g. for welfare recipients and self-payers).</p> <p>As a carrier, you can also display for several facilities.</p> <p>You do not have to include more detailed calculation reasons.</p>
