Teaser	If you live in a registered partnership, you can choose a common name (civil partnership name).
Volltext	Life partners may determine a common civil partnership name during the existence of the registered civil partnership, provided that they have not already done so when establishing the civil partnership. The life partner whose name does not become a civil partnership name may prefix or add his/her birth name or the name used at that time to the civil partnership name. The name from a previous civil partnership, including a possible accompanying name, can also be considered as an actual name. Once you have chosen, you may not change the common civil partnership name during the existence of the civil partnership. Foreign life partners are generally subject to the naming rights of their home country. If one of the partners has his habitual residence in Germany, there

	is a right to choose between the law of the state to which the foreign partner belongs and German law.
