It enables people working in the healthcare professions in an institution to access the telematics infrastructure (TI). The TI networks all those involved in the healthcare system and will enable access to the electronic patient file (ePA) in the future, for example.</p> <p>There are different SMC-Bs for different professional groups. There is an SMC-B for</p> <ul style="list-style-type: none"> • medical practices • Nursing, obstetrics and physiotherapy facilities • pharmacies <p>You can use this online service to apply for an SMC-B for institutions with employees that are not organized in chambers.
