| Teaser | If you would like to work independently on a non-essential activity of a craft subject to licensing and have a relevant journeyman's training, you must be entered in the register of your locally responsible Chamber of Crafts. |
| Volltext | <p>Chambers of Crafts represent the interests of the entire craft sector in a chamber district. Their task is to promote the region's businesses and support their interests through self-management.</p> <p>If you are self-employed in a non-essential activity of a craft subject to licensing, which quantitatively accounts for the majority of your commercial activity and is carried out in the form of a craft business, and if you have a journeyman's training in a craft subject to licensing, the training content of which has prepared you for the activity carried out, you are a compulsory member of the Chamber of Crafts.</p> <p>When you commence your commercial activity, you must apply for entry in the register of persons pursuant to § 90 (3) and (4) HwO. The Chamber of Crafts in whose district your commercial establishment exists is responsible.</p> |
