Teaser	<p>You have obtained the professional qualification "Nurse" abroad and want to work as a specialist in Germany. Since this profession is regulated in Germany, you must have your professional qualification recognised.</p>
Volltext	<p>The activity of a nurse is regulated in Germany.</p> <p>This means that in order to work in this profession in Germany, you need a state permit. With this permit, you are allowed to use the professional title of the respective profession and work in the profession.</p> <p>In order to obtain the permit, you must have your foreign professional qualification recognised. In the recognition procedure, the competent authority compares your professional qualification from abroad with the German professional qualification and checks its equivalence. The equivalence of the professional qualification is an important prerequisite for the issuance of the state permit.</p> <p>If there are significant differences to German training, these can often be compensated for by an adaptation measure. In addition to the equivalence of the professional qualification, you must also meet other requirements for the issuance of the permit. Other requirements are, for example, sufficient German language skills and health suitability.</p> <p>You can also apply for the procedure from abroad.</p>

Bearbeitungsdauer	<p>The competent authority will confirm that your documents have arrived within one month. The competent authority will inform you if any documents are missing. If the documents are complete, the examination of the equivalence of the training will take a maximum of 4 months.</p>

Fristen

No later than one month after receipt of your application by the competent authority: The competent authority will inform you of the receipt of the documents. It will let you know if any documents are missing. The procedure starts when the documents are complete.

After 4 months at the latest: You will receive a notification with the result.

- * Apply for state recognition as a nurse with a professional qualification from the EU/EEA/Switzerland
- * To work as a nurse in Germany, you need a state permit.
- * With the permit, you can legally call yourself a "health and nursing nurse" and work in the profession.
- * Even with professional qualifications from the European Union (EU), the European Economic Area (EEA) or Switzerland, you can obtain a state permit in Germany.
- * The Hessian State Office for Health and Care is responsible
