Volltext	You require a permit for the commercial transportation of passengers by bus or coach. If you wish to increase the number of vehicles or seats for your bus and coach company, you must apply for an extension of the permit from your competent licensing authority.

Voraussetzungen	 The applicant is already in possession of a bus and coach permit as an entrepreneur. The safety and efficiency of the operation is guaranteed. There are no facts indicating the unreliability of the applicant as an entrepreneur or of the person appointed to manage the business. The applicant as entrepreneur or the person appointed to manage the business is professionally qualified. The applicant and the entrepreneurs commissioned by the applicant to provide transportation services must have their registered office or branch in Germany within the meaning of commercial law. Legal entities under public law are deemed to meet the requirements.
