Verfahrensablauf	• The application for direct payments within the framework of the joint application takes place annually until 15.05 of the current year exclusively via an online application (agrarportalhessen.de) • Depending on the other requirements, the application for the individual components such as basic income support, supplementary redistributive income support, supplementary income support for young farmers and organic regulations takes place within the framework of the joint application.
Bearbeitungsdauer	7 - 12 Monat(e) Individually dependent on the size and shape of the company. There is no legal processing period for the funding programme.
