Voraussetzungen	• You have completed the prescribed training and passed the state examination, • You have not been guilty of conduct that results in unreliability in the exercise of the profession, • They are not unfit for the exercise of the profession from a health point of view, • You have the knowledge of the German language required to carry out your professional activity.
