Teaser	Are you receiving an advance on maintenance and have there been any changes? Report them immediately.
Volltext	For the entire period of receipt of benefits, you must notify the maintenance advance office of any important changes. You must notify any changes that may be important to the claim or about which you have made declarations in connection with the maintenance advance. You must notify us of the changes within 14 days at the latest. Examples of changes: • Your child no longer lives with you • You're moving. • They get married. • You move in with the other parent. • The other parent is paying alimony again or wants to pay maintenance again. • You will become aware of the previously unknown whereabouts of the other parent. • The other parent died.

	• The child died. • The child no longer attends school. • In the case of a child who no longer attends school, the income changes (for example, because the amount of the training allowance changes) Notifications to other authorities are not sufficient. An intentional or negligent breach of these obligations is an administrative offence and can be prosecuted or punished with a fine. In addition, the benefits paid can be reclaimed.
Erforderliche Unterlagen	Varies from case to case.
Voraussetzungen	
Kosten	The procedure is free of charge.
Verfahrensablauf	You inform the maintenance advance office of any changes that may be important for the entitlement or about which you have made declarations in connection with the maintenance advance. Upon receipt, the maintenance advance office will check whether there is still a claim.
Bearbeitungsdauer	The duration of the processing depends on the current personnel and work situation of the maintenance advance office.
Frist	For the entire period of receipt of benefits, you must immediately inform the maintenance advance office of any changes in your circumstances.
