Teaser	If you have to prove orderly economic circumstances vis-à-vis other bodies, the competent insolvency court may issue you with a certificate of the absence of insolvency proceedings or insolvency applications.
Volltext	With a negative certificate of the pending insolvency proceedings, you can prove orderly economic circumstances vis-à-vis other bodies. The insolvency court examines whether an insolvency application has been filed, insolvency proceedings have been opened or rejected for lack of assets and then issues a certificate. In principle, you can also apply for the negative certificate via a third person. The insolvency court will then also check whether you have a legitimate interest in the information. A legitimate interest must therefore be demonstrated to the court when filing the application (if necessary with appropriate evidence).

	• If the application is made by representation or power of attorney, suitable evidence must be submitted showing the power of representation or existing power of attorney. • If a certificate is to be issued for a third person, documents proving the legitimate interest of the applicant must be submitted, if applicable.
Voraussetzungen	In principle, the issue of a negative certificate is not subject to any conditions. Only in the event that you want to receive a negative certificate about a third person, you must have a legitimate interest.
Kosten	There is a fee of 15.00 euros.
Verfahrensablauf	
Bearbeitungsdauer	As a rule, processing takes place within a few days of receipt of the application.
Frist	There are no deadlines to be observed.

Rechtsbehelf	If the issue of the negative certificate is refused, a review of legality pursuant to § 23 GVG can be requested.
Kurztext	• Negative certificate of pending insolvency proceedings • Negative certificate is required, for example, if a certain trade is to be opened (results from the Industrial Code) • Certificate may be issued through the applicant himself or through a third person • If a certificate is to be issued by the applicant himself, no proof must be provided • If a certificate is to be issued by a third person, legitimate interest must be demonstrated • Costs of 15 EUR are incurred when applying • Jurisdiction: Insolvency court at the district court
