Teaser	A certificate is required for VAT exemption purposes, which you should apply for in advance. Itis a basic notification on the basis of which the further requirements for tax exemption are checked by the tax authorities.
Volltext	The services of private schools and other general education or vocational training institutions that directly serve the purpose of education and training are tax-exempt if the competent state authority certifies that they properly prepare students for a profession or an examination to be taken before a legal entity under public law. For the purposes of VAT exemption, you require a certificate from the competent authority, which you can apply for from the Hessian State Office for Health and Care as a general and vocational training institution for services in the health, medical and social professions. For the tax authorities, the certificate constitutes a so-called basic decision, on the basis of which the tax office will check the further requirements for tax exemption.
