Verfahrensablauf	<p>Notify your competent housing benefit authority immediately of any changes that could lead to a reduction or elimination of your housing benefit. The housing benefit authority will then check whether and how the changes affect your housing benefit entitlement and inform you of the result. Overpaid housing benefit will be reclaimed.</p>

Frist	<p>Changes that could lead to a reduction or elimination of housing benefit must be reported immediately to your competent housing benefit authority.</p>
