Volltext	You require a permit from the competent authority if you:  • wish to set up and operate an installation requiring monitoring or  • wish to make changes to the design or mode of operation that affect the safety of the system.  Permission may be granted subject to the following restrictions:  • limited,

	If the installation requiring a permit is part of an installation requiring a permit no separate permit is issued. The approval includes the permit.
Erforderliche Unterlagen	Informal application with the following details:  • Surname, first name, company name • Address of the applicant • Contact information (e-mail, telephone number, fax) • Type of permit: • Establishment and operation • Modification and operation or • Partial permit • Specification of the operating site • Test report from an approved inspection body (ZÜS) • The test report must confirm that the system can be operated safely if the specified measures are
Voraussetzungen	<ul> <li>The installation for which you are applying for a permit must be an installation requiring a permit.</li> <li>You must construct and operate the installation requiring monitoring in accordance with the state of the art.</li> <li>Your documentation must be complete, plausible and meaningful.</li> <li>The test report from the approved inspection body (ZÜS) must confirm that the system applied for can be operated safely if the measures specified in the documents, including the tests, are complied with.</li> </ul>
Kosten	Administrative fees will be charged in accordance with the applicable administrative cost regulations.
Verfahrensablauf	<ul> <li>Submit the application for approval of the system requiring monitoring with the required documents including the test report from the approved monitoring body (ZÜS) to the responsible authority.</li> <li>If a permit is required in accordance with the Federal Immission Control Act, you will receive the application documents back, as a permit in accordance with the Industrial Safety Ordinance will then also be checked as part of the necessary permit in accordance with the Federal Immission Control Act.</li> <li>The competent authority will make its decision after examination and inform you.</li> </ul>

Bearbeitungsdauer	0 - 3 Monat(e) The processing time applies from receipt of the complete application documents. An extension of the processing period is possible in justified cases.
Frist	A permit issued expires if: • you have not commenced construction of the installation within two years of the permit being issued, • you have interrupted the construction of the installation for two years or longer or • you have not operated the installation for a period of three years. You can apply to the licensing authority for an extension of the deadlines for important reasons.
