Teaser	If you are a young foreigner wishing to hunt in Germany and have not passed a German hunting examination, you must carry a foreigner's hunting license in your name.
Volltext	If you are a foreign citizen and would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth hunting license for foreigners in your name If you do not provide proof of a German hunting examination, you can apply for a youth hunting license for foreigners under certain conditions.

	The application and the supporting documents to be provided will be checked for completeness and correctness.
	If you meet all the requirements, you will be issued with a youth hunting license for foreigners.

Frist	The annual hunting license is valid for a maximum of two consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03

Hinweise	With a youth hunting license, you may only hunt when accompanied by a guardian with hunting experience or an experienced hunting supervisor authorized in writing by your guardian(s).
	The youth hunting license must be presented to the authorized hunting guardians and police officers upon request.
	With a youth hunting license, you are not allowed to participate in social hunts.

Kurztext	<ul> <li>Youth hunting license for foreigners Issue of annual hunting license</li> <li>required for hunting in Germany</li> <li>for non-German citizens who have passed an examination comparable to the German hunting examination</li> <li>Prerequisite is that they do not have their main residence in Germany</li> <li>Proof of aptitude for proper hunting must be provided by presenting a hunting license issued within</li> </ul>

	<ul> <li>the last three years</li> <li>for persons who are at least 16 and under 18 years old</li> <li>is valid for a maximum of 2 consecutive years</li> <li>must be accompanied by a legal guardian or authorized representative with hunting experience</li> <li>no participation in social hunting</li> <li>is issued by the authority in whose jurisdiction the hunt is to be predominantly practiced</li> <li>Responsible: lower hunting authority</li> </ul>
