Volltext	If you wish to hunt in Germany, you will need a German hunting license in your name. If your annual hunting license for foreign youngsters has been revoked, you can reapply for it at the authority that revoked your hunting license after the expiry of the specified retention period.
Erforderliche Unterlagen	• current photograph, if applicable • Proof of statutory hunting liability insurance • Consent of the person with custody
Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue • personal reliability • physical fitness • completed hunting liability insurance • already issued youth hunting license withdrawn • consent of the legal guardian • Elapsed ban period

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority.

	The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued with a youth hunting license for foreigners.

Frist	The annual hunting license is valid for a maximum of three consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03..
