Teaser	If you are a foreigner wishing to hunt in Germany and have not passed a German falconry examination, you must carry a foreigner's falconry license in your name.
Volltext	If you are a foreign national and wish to hunt in Germany, you will need a German falconry license and hunting license in your name. If you do not provide proof of a German falconry and hunting examination, you can only apply for a day hunting license for foreigners.
Erforderliche Unterlagen	• identity card • Hunting license issued by the home country in the last three years • falconry license issued by the home country in the last three years • current photograph • Proof of statutory hunting liability insurance
Voraussetzungen	• at least 18 years old at the time of issue • Main residence not in Germany • personal reliability • physical fitness • completed hunting liability insurance • passed falconry examination

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority.

	The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a foreigner falconry hunting license.

Frist	The daily hunting license is valid for 14 consecutive days.
