Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a falconry license.
