Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth falconry hunting license in your name. If you already have a day hunting license but its validity has expired, you can apply for an extension.

Frist	The daily hunting license is valid for 14 consecutive days.

Hinweise	• The youth hunting license only entitles you to hunt when accompanied by a person with parental authority or a supervisor appointed in writing by the person with parental authority. The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in group hunts.
