Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth falconry hunting license in your name. If you already have an annual hunting license but its validity has expired, you can apply for an extension.

Frist	The youth falconry hunting license is valid for a maximum of two consecutive hunting years. A hunting year begins on 01.04. and ends on 31.03. of each year.

Hinweise	• The youth hunting license only entitles you to hunt when accompanied by a person with parental authority or a supervisor appointed in writing by the person with parental authority. The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in group hunts.

Kurztext	• Youth falconry hunting license New issue of annual hunting license • required for hunting in Germany • Persons who already hold or have held a German falconry hunting license • for persons under 18 years of age, minimum age 16 years • Possession of a hunting license or special hunting license for falconers is required • Hunting is only permitted when accompanied by a parent or legal guardian with hunting experience • No participation in social hunting • Annual hunting license is valid for a maximum of two consecutive hunting years • Hunting year begins on 01.04. and ends on 31.03. • Responsible: lower hunting authority
