Teaser	If you already have a driving license, you can extend it with a category B driving license as part of accompanied driving.
Volltext	<p>You can apply for an extension of your driver's license to include category B as part of accompanied driving from the age of 17 at the driving license authority responsible for you.</p> <p>If you take part in "accompanied driving from 17", the minimum age for obtaining a category B and BE (passenger car) driving license is reduced to 17. The driving school training can be started earlier.</p> <p>After successfully passing the driving test, you will receive a test certificate as proof of your driving license in Germany, which is valid for a maximum of three months after reaching the age of 18. However, you may only drive the car until your 18th birthday if accompanied by a person named on the test certificate. The accompanying person must meet certain requirements.</p> <p>Once you have reached the age of 18, you can apply for an EU driving license valid throughout Europe.</p>

Information and examples can be found in the photo sample table (Bundesdruckerei) • Proof of first aid training • Eye test certificate or certificate or expert opinion from an ophthalmologist, not older than two years at the time of application • Declaration of consent from the parent or legal guardian <p>Documents for accompanying persons:</p> <ul style="list-style-type: none"> • Application form for each accompanying person • Valid identity card or passport • Copy of valid driving license
Voraussetzungen	<p>For applicants:</p> <ul style="list-style-type: none"> • Minimum age 17 years • Ordinary residence in the Federal Republic of Germany <p>For accompanying persons:</p> <ul style="list-style-type: none"> • Completion of the 30th year of age • have held a valid category B driving license or a corresponding German, EU/EEA or Swiss driving license for at least five years • no more than 1 point on the driving aptitude register at the time of application.
Kosten	The fees are based on the scale of fees for road traffic measures (GebOSt).
Verfahrensablauf	You must submit an application for an extension for accompanied driving from the age of 17 to the driving license authority responsible for you.
Bearbeitungsdauer	The processing time depends on the workload of the responsible driving license authority.
Frist	An application may be submitted at the earliest six months before the age of 17. The examination certificate is valid for a maximum of three months after the age of 18.

Hinweise	<p>If a BF 17 participant drives a motor vehicle without being accompanied by a named person, the driving license must be revoked. In addition, there is a fine, a point in the driving aptitude register, an extension of the probationary period and an order to attend an advanced training seminar.</p> <p>The accompanying person must not be under the influence of alcohol (0.25 mg/l or more breath alcohol or 0.5 per mille or more blood alcohol) or under the influence of narcotics.</p>

Kurztext	<ul style="list-style-type: none"> • Driving license extension for accompanied driving from the age of 17 for category B • the applicant can extend their driving license to include category B as part of accompanied driving from the age of 17 • When participating in accompanied driving from the age of 17 (BF 17), the minimum age for obtaining a category B and BE driving license is reduced to 17. • Accordingly, driving license training in driving schools can be started at the age of 16½. • Responsible: the relevant driving license authority (usually that of the place of residence)
