Teaser	If the holder of a mining permit dies, the right to the permit is transferred to the heirs.
Volltext	A mining permit, also known as an exploration permit, allows you to explore for certain raw materials in a specified area and for a specified period of time. If the holder of a mining permit dies, it is transferred to the heirs. Up to 10 years after the death, the right may also be exercised by the so-called beneficiaries. These are • Administrators of the estate • estate administrators • executors of the will. In both cases, you as the heir or person entitled to dispose of the estate must apply to the competent authority for a transfer of the license.

Voraussetzungen	• The holder of a mining permit dies. • They, or their representatives, must have the necessary legal reliability.

Verfahrensablauf	You can apply to transfer your permit online via the "BergPass" platform or in writing to your local mountain authority. Apply for a permit transfer online: • Go to the "BergPass" online platform and log in. • To register, you will need a BundID and an identity

card or residence permit with an active online ID function.

- Call up the application form and fill it out completely and truthfully.
- Upload the required documents as a file and send the application.

Apply in writing for the permit to be transferred:

- Contact your responsible mining authority and coordinate the required application documents.
- Submit the application and all required documents.

Further procedural steps:

- The competent authority will check your notification and the documents submitted. If any documents are missing, the authority will contact you.
- You will receive a notification by post informing you of the decision on your application. In addition, the decision will be sent electronically to the relevant mailbox (BundID or ELSTER company account) in advance and information will be displayed in BergPass.
