Teaser	In addition to the registered office, which is the center of operations and corresponds to the location of the main office, inspection experts and authorized inspectors for structural stability can apply to the recognition authority for secondary offices.
Volltext	The application for approval to set up a second branch as an authorized inspector or inspection expert for structural stability in accordance with Section 5 (4) of the Hessian Ordinance on Authorized Inspectors and Inspection Experts (HPPVO) relates to the authorization to work in Hesse as an authorized inspector or inspection expert for the structural stability of buildings. Here are some key elements that are usually included in such an application: The authorization to establish a secondary
	establishment as an authorized inspector or inspection expert for structural stability is usually granted or denied by the competent authorities based on the information submitted and the fulfillment of the legal requirements.

	<ul> <li>Information on proof of professional qualification and scope of employment</li> <li>Confirmation that the employees are permanently employed with a written employees who are to be deployed at the requested second branch office to assist with the testing of stability certificates and building inspections</li> <li>Information on proof of professional qualifications and scope of employment</li> <li>Confirmation that the employees have a written permanent employment contract</li> <li>Confirmation that the employees have agreed to work at the second location</li> <li>Description of the measures taken to ensure that you only make use of the cooperation of my employees at the registered office and in the second branch in your audit activities to such an extent that their activities can be fully monitored by you at all times</li> <li>Information to ensure the proper supervision of the construction work by the authorized inspectors/experts</li> <li>Information on the approximate time distribution of the inspection activities between the registered office and the second branch office</li> <li>Information on the responsibility for the activities in the second branch office</li> <li>The necessary evidence (e.g. copies of the relevant articles of association or partnership agreements) must be submitted for this purpose</li> <li>Information on other, already approved secondary branches</li> </ul>
Voraussetzungen	<ul> <li>Recognition as an expert/authorized inspector for structural stability</li> <li>Fulfillment of the requirements in the documents</li> </ul>
