Note: If the application is submitted after the expiry of the FzF, an extension is no longer possible. The issuance of a new FzF must be applied for.
Erforderliche Unterlagen	• official proof of place and date of birth (e.g. identity card or passport) • Current certificate of registration, if applicable • EU/EEA driving license • Certificate of good conduct for submission to an authority (service description in Hessenfinder) • Current information from the driver suitability register • Proof of physical and mental fitness • Proof of meeting the requirements for eyesight • Proof of ability to cope with stress, orientation, concentration, attention and reaction (in case of extension beyond the age of 60)
