| Volltext                   | <p>Home slaughter is slaughter outside commercial slaughterhouses, whereby the meat may only be used in the owner's own household.</p> <p>Anyone who slaughters animals must have the necessary knowledge and skills.</p> <p>In the case of domestic slaughter, notification for official ante-mortem inspection for domestic or farmed ungulates shall only be made if the owner of the animal has noticed a disturbance in the general condition of the animal immediately before the intended slaughter which is not attributable to an accident that occurred immediately before.</p> <p>Bovine animals, pigs, sheep, goats and other biungulates, horses and other solipeds are subject to official post-mortem inspection, which must also be carried out at home slaughter, provided that their meat is intended for human consumption.
