Teaser	If you have concluded a land lease agreement or wish to notify a change to it, this must be reported to the competent authority by the landlord within one month.
Volltext	Land lease agreements for farms or plots of land up to one hectare are exempt from the notification requirement in Hesse. All other land lease agreements concluded or amendments thereto must be notified to the competent authority by the landlord within one month. Notification of land lease agreements can also be made by the tenant, who is entitled to do so.
Erforderliche Unterlagen	Concluded land lease agreement or amendments, with details of the sender
Voraussetzungen	Contract concluded in accordance with the provisions of § 585 BGB, stating: Lessor, lessee, property name, lease term, lease price
Kosten	There are currently no fees.
Verfahrensablauf	The land lease agreement concluded between the landlord and the tenant is submitted to the competent authority by the landlord or the tenant within one month.

	The competent authority checks the contract for completeness with regard to the assessment under the LPachtVG.
Bearbeitungsdauer	Within the 1-month period
Frist	The decision on the objection to a land lease agreement or an amendment to the agreement must be made in writing within one month of notification of the conclusion of the agreement or the amendment to the agreement. If the examination of the land lease contract is likely to take longer, the parties to the contract must be issued with an interim decision before the deadline expires, which extends the deadline to two months.

Kurztext	The landlord must notify the competent authority within one month of every land lease agreement concluded or amendment thereto. Land lease agreements may also be notified by the tenant, who is entitled to do so.
Ansprechpunkt	
Zuständige Stelle	The competent authorities are the agricultural authorities of the districts in whose district the lessor's farm is located. If there is no such farmstead, the authority in whose district all or most of the leased land is located is responsible.
