Volltext	The term "publicly appointed expert" is protected by law. Experts are responsible for the technical and qualitative control of products and services in a specialist area. Experts shall make their objective, knowledgeable competence available to the public. Typical estimation cases exist if: • requires independent professional advice or information, • assesses damage or determines a cause of damage, • evaluates a thing, • a professional dispute has been resolved in or out of court, • established the actual condition of an object, e.g. for evidentiary purposes is to be used.
