Verfahrensablauf	• An application for suitability for the installation site must be submitted prior to the installation of gambling machines. • The application must be made in writing. • When setting up in restaurants, the operator of the restaurant must have a restaurant license.

Kurztext	• In order to be allowed to set up gaming devices that offer a possibility of winning, the suitability of the place of installation must be determined. • Pursuant to Section 33c of the German Trade, Commerce and Industry Regulation Act (Gewerbeordnung), proof must be provided for each location where gambling devices with the possibility of winning are set up that it is suitable for this purpose.
