Volltext	The Point of Single Contact (PSP) is the central intermediary between the public administration and the (foreign) service provider. You can carry out all the procedures and formalities necessary for the commencement and exercise of your service through the Point of Single Contact. The prerequisite for this is that this service falls within the scope of Directive 2006/123/EC of the European Parliament and of the Council of 12.12.2006 (EC Services Directive). The Point of Single Contact receives your application documents and forwards them to the authorities responsible for your intended service activity. The Point of Single Contact will take over the further coordination of your project for you. The EAH receives the notices issued by the competent authorities and forwards them to you. Erforderliche Unterlagen	You can submit your application via the service platform (of the state of Hesse). You can also contact the Point of Single Contact in person, by telephone, fax or e-mail.
Voraussetzungen	
Kosten	The service of the Point of Single Contact is usually free of charge. Costs are incurred only in exceptional cases in complex procedures with greater administrative effort.
