Volltext	If a company is founded or renamed whose company name contains the legally protected professional titles architect, landscape architect, interior designer, urban planner or urban architect or a derived designation or word formation (= professional company), a clearance certificate from the chamber vis-à-vis the partnership or commercial register is required. On the basis of the articles of association, the list of shareholders and the proof of professional liability insurance, the Chamber of Architects and Urban Planners checks whether the legal requirements under the Hessian Architects and Urban Planners Act have been complied with. If the prerequisites are met, the Chamber issues a clearance certificate and sends it to the competent partnership or commercial register. Upon entry in the partnership or commercial register, the professional society is

	entered in the professional directory of professional societies of the Hessen Chamber of Architects and Urban Planners and becomes an independent member of the chamber.
