The obligation to notify exists regardless of whether the activities are previously reported and have already been carried out by another responsible person or whether they are new activities that have not yet been notified. There is no obligation to notify employees who work under the supervision of a person who has the necessary permission to work with pathogens. The competent authority shall examine the existing premises, facilities and disposal measures. A notification of change is required if, compared to a previous notification, there are significant changes in the quality of the rooms and facilities, the disposal measures or the nature and scope of the activities.
