The permit authorizes the care of up to five foreign children present at the same time. In individual cases, permission may be granted for a smaller number of children.

The permit is limited to five years.

## Erforderliche Unterlagen

For the application procedure and advice on permission for child day care, please contact the Youth Welfare Office in whose area you exercise or would like to exercise child day care.

## Voraussetzungen

Permission must be granted if the person is suitable for child day care. Suitable are persons

- who are characterized by their personality, expertise and willingness to cooperate with legal guardians and other child day care workers and
- which have child-friendly premises.

Child day care workers should have in-depth knowledge of the requirements of child day care, which they have acquired in qualified courses or otherwise demonstrated.

An extended certificate of good conduct is necessary for all those who supervise, supervise, educate or have comparable contact with children in child day care.

All child day care workers born after 1970 must prove protection against measles through the completed measles vaccination or measles immunity.

The requirements are checked by the responsible youth welfare office in each individual case on the basis of the applicable legal provisions and own regulations.
