Teaser	You can take advantage of health examinations for your children. In this way, a child's general state of health and age-appropriate development are regularly examined by a doctor. Possible problems or abnormalities can be detected and treated at an early stage.
Volltext	<p>The statutory health insurance funds cover the costs of medical screening examinations for insured children and adolescents, also known as U examinations and J examinations. The examinations are available to children and adolescents up to the age of 18. They serve the early detection of diseases that endanger their physical, mental or psycho-social development. Until the age of six, this also includes early detection examinations for dental, oral and maxillofacial diseases, e.g. determination of the caries risk and advice on nutrition and oral hygiene.</p> <p>The details of the content, type and scope of the examinations are regulated by the Federal Joint Committee in the guideline on the early detection of diseases in children (U1 to U9) of the guideline on youth health examinations (J1).</p>
Erforderliche Unterlagen	For the examinations, you will need your child's electronic health card and the children's examination booklet ("Yellow Booklet"), which you will receive immediately after birth.
Voraussetzungen	<p>In principle, insured children and adolescents are entitled to early detection examinations until they reach the age of 18. However, the following examination periods must be observed:</p> <ul style="list-style-type: none"> <li>• U1 Immediately after birth</li> </ul>
