Volltext	<p>If there is an emergency in the supply of medicines because there are no pharmacies to supply the population, you as the owner of a nearby pharmacy can apply for permission to operate a branch pharmacy. Branch pharmacies have fewer facilities than normal pharmacies, but these are also regulated by law.</p> <p>Branch pharmacies must be managed, and the manager needs a permit from the relevant authority.</p> <p>You will not normally be granted a permit for more than one branch pharmacy.</p> <p>The permit is granted to you for 5 years, it can be reissued.</p>
