Teaser	If you are unable to walk alone in public because of a disability, then you may be exempt from having an ID card.
Volltext	<p>If you cannot move alone in public because of a disability, then you can be exempted from the obligation to have an ID card - that is, from the obligation to have an ID card.</p> <p>This is the case, for example, if you can no longer leave the house alone because of a disability. You can cancel the exemption at any time. All you need to do is apply for an ID card or a passport.</p>

Voraussetzungen	<ul style="list-style-type: none"> • You must have German citizenship. • You must be at least 16 years old. • You cannot move alone in public due to a permanent disability. • You must be registered with your main residence in your municipality.
Kosten	There are no costs involved.
Verfahrensablauf	<p>You must apply for exemption from the ID card requirement in writing.</p> <ul style="list-style-type: none"> • You complete the application for exemption from the ID card requirement in full or • You or a caregiver sign the application. • You attach the necessary documents. • You send the application and the documents to the competent ID card authority in your municipality or • You go in person to the competent authority. • The authority issues you an unlimited certificate stating that you are exempt from the ID card requirement. • If you apply in person, you will immediately receive confirmation of the exemption. If you apply in writing, the competent authority will send you the confirmation.
