Teaser	Would you like to live in Germany indefinitely? Under certain conditions, as a foreign national you can apply for an EC permanent residence permit. This allows you to move more freely within the European Union (EU).
Volltext	With the EC permanent residence permit, foreign nationals can move more freely within the European Union (EU). It is equivalent to a settlement permit in many respects and is a permanent residence permit. If you meet the requirements, you can apply for a so-called permit for permanent residence in Germany. The foreigners authority in your place of residence is responsible for this.

Voraussetzungen	• Your identity has been established and you fulfill the passport and visa requirements. • You have been living in Germany with a residence permit for at least 5 years without interruption. • Your livelihood and that of your dependents to whom you provide support is secured by regular income. • You are insured in the statutory health insurance scheme or have unlimited health insurance cover. • You have paid contributions into the statutory pension insurance scheme or another pension scheme with comparable benefits. • You have sufficient knowledge of German and basic knowledge of the German legal and social system. • You have sufficient living space for yourself and your family. • There are no grounds for deportation against you.
