|                                  | The circle of family members to be taken into account is defined by the characteristic of family community and the obligation to support.   |

| Voraussetzungen | <ul> <li>You have been in possession of a residence permit<br/>for entrepreneurial self-employment (not freelance) for<br/>three years.</li> <li>Your residence permit was issued in accordance with<br/>Section 21 (1) or (2a) of the Residence Act for a<br/>self-employed, entrepreneurial activity.</li> <li>You are in a position to secure the livelihood<br/>(including health insurance) for yourself (and your<br/>family) independently - i.e. without claiming public<br/>benefits - with the income from your entrepreneurial<br/>activity (income of your family members or profits from<br/>capital assets cannot be taken into account).</li> <li>You can prove that you have sufficient retirement<br/>provisions.</li> <li>There are no reasons of public security and order<br/>against your stay in Germany (you are exempt from<br/>punishment).</li> </ul> |
| Kosten          | Cost amount (fee): 124,00<br>Remark:<br>For the issuance of the settlement permit in the form<br>of the electronic residence permit, which can also be<br>used as an electronic proof of identity, additional fees<br>may be charged.<br>The timing and form of fee collection as well as<br>payment varies depending on the authority.<br>Lower fees may apply for Turkish nationals.  |

| Verfahrensablauf                | <ul> <li>The settlement permit must be applied for before the validity of your current residence permit expires.</li> <li>Find out whether your Aliens' Registration Office allows you to apply online or has a special application form.</li> <li>If the application can only be submitted in person, make an appointment at the Aliens' Registration Office. In the case of online application, the Aliens' Registration Office will contact you after receiving your application to schedule an appointment.</li> <li>During the appointment, your identity and documents will be checked (please bring your documents, if possible in original, to the appointment).</li> <li>If your application is granted, your fingerprints will be taken for the production of the settlement permit in the form of the electronic residence permit (eATKarte).</li> <li>The Foreigners' Registration Office will order the production of the eAT card from the Bundesdruckerei. After completion, you will receive information and can pick up the eAT card at the responsible office. The eAT card must always be collected in person.</li> <li>If your application is rejected, you will receive a rejection notice.</li> </ul> |
| Bearbeitungsdauer               | Duration (with span): approx. 6 to 8 Note for further<br>information on processing time: The processing time<br>may vary depending on the workload of the Foreigners'<br>Registration Office. It takes about 4 weeks to 6 weeks<br>for the Bundesdruckerei to produce the electronic<br>residence permit.   |
| Frist                           | Duration (for span): 6 to 8 Remark (for more<br>information on the deadline): At least six to eight<br>weeks before your visa or current residence permit<br>expires, the application should be received by the<br>Foreigners' Registration Office. The settlement permit<br>is issued for an unlimited period of time. Only the<br>electronic residence title (eAT card) is issued for a<br>limited period of time and must be renewed at the end<br>of its validity.  |

Other requirements then also<br/>apply.</li> <li>The procedure is usually conducted in German.</li> <li>A settlement permit can expire if you stay outside<br/>Germany for more than six months, if this stay abroad<br/>was not previously agreed with the Foreigners<br/>Authority.</li> <li>All information provided to the Foreigners'<br/>Registration Office should be correct and complete to<br/>the best of your knowledge and belief, so that the<br/>request can be processed without major delays.</li> <li>Incorrect or incomplete information can slow down<br/>the process and be detrimental to the person<br/>concerned. In a serious case, incorrect or incomplete<br/>information that is not completed or corrected in time<br/>vis-à-vis the Aliens Department may result in the<br/>revocation of residence rights already granted, a fine, a<br/>prison sentence of up to three years, or expulsion from<br/>the Federal territory.</li> <li>Due to the complexity of the right of residence, this<br/>description is for information purposes only and is not<br/>legally binding.</li> </ul> |
| Rechtsbehelf  | <ul> <li>Appeal against the decision of the Foreigners'<br/>Registration Office within one month of notification.</li> <li>Action before the court named in the notice of<br/>objection if the objection is not upheld.</li> </ul>   |
| Kurztext      | <ul> <li>Settlement permit issued for self-employed activity</li> <li>Holders of a residence permit for the purpose of<br/>self-employment may be granted a permanent<br/>residence title (settlement permit) after three years if<br/>the foreigner has successfully realized his business<br/>idea and the livelihood for him and his family members<br/>continues to be secured.</li> <li>The settlement permit is an independent right of<br/>residence, independent of the original purpose of<br/>residence, which entitles the holder to pursue gainful<br/>employment without restriction.</li> <li>Responsible: the foreigners authority responsible for<br/>the applicant's place of residence.</li> </ul>   |
