Erforderliche Unterlagen	• Application • Documents proving the disability (assessment notice in accordance with the law on severely disabled persons). • passport photo, if applicable Exception: In the case of severely disabled persons who cannot leave the house or can only do so with the help of an ambulance, the ID card will be issued without a photograph on application. The issuing authority will then note "valid without photo" on the ID card. • for non-EU citizens: valid residence permit The competent authority may request further documents from you if necessary.
