Teaser	If you want to use the job title "health inspector" or "hygiene inspector", you need a permit. You can find out more here.
Volltext	As a health supervisor or hygiene inspector, you are responsible for monitoring hygiene standards in various facilities such as clinics or food stores. This is a recognized training occupation. The job of health inspector is regulated in Germany. This means that in order to work as a health inspector or hygiene inspector in Germany, you must apply for a state permit. With this permit, you can use the job title "health supervisor" or "hygiene inspector" and work in the profession. The professional permit is issued after passing the state examination or recognition of the foreign professional qualification, if the health and personal aptitude (reliability) and the knowledge of the German language required for practicing the profession are present.
Erforderliche Unterlagen	Copy of the certificate confirming that you have

	completed the training period prescribed by the relevant law and passed the state examination
Voraussetzungen	The permit is issued if you have passed the state examination for health supervisors or hygiene inspectors after completing the relevant training.
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.
Verfahrensablauf	You must apply for the permit from the competent authority. Once you have submitted the application and all documents are complete, the competent authority will check whether you meet all the requirements. If you meet all the requirements, you will receive the permit. You may only start working once you have received the permit.
Bearbeitungsdauer	The processing time varies. If the documents are complete, your application will be processed promptly.
Frist	There are no deadlines to be observed.
weiterführende Informationen	Comparable training qualifications obtained outside Germany can be recognized as equivalent. If you have completed the relevant training outside Germany, you may (in accordance with EU law) be able to work as a service provider in Germany temporarily and occasionally without a permit. You must notify the competent authority of this in advance.
