Volltext	The job title "Medical-technical assistant for functional diagnostics" is regulated in Germany. This means that in Germany you can work as a medical-technical assistant for functional diagnostics in Germany, you must apply for a state permit. With this permit, you can use the professional title and work in the profession. As with all medical-technical professions, the professional license is issued after you have passed a state examination, provided you have the necessary health and personal aptitude (reliability). Areas of activity include Hospitals, medical practices.

Voraussetzungen	The license is granted if you • have passed the state examination as a medical-technical assistant for functional diagnostics following training,

	• have not been guilty of any conduct that makes you unreliable to practice the profession, • are medically fit to practise the profession, • have the necessary knowledge of the German language to exercise the profession.
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.
Verfahrensablauf	Once you have submitted the application and all the documents are complete, the competent authority will check whether you meet all the requirements. If you meet all the requirements, you will receive the permit. You may only start working once you have received the permit.
