Teaser	If you wish to complete your training in the field of child and adolescent psychotherapy, you must pass a state examination. Admission to the examination is by application. You can find out more here.
Volltext	To practice the profession of child and adolescent psychotherapist, the person needs to have completed training in accordance with the legal requirements, passed the state examination and obtained a license to practice.
	Training in the field of child and adolescent psychotherapy concludes with a state examination. It comprises at least 4,200 hours and consists of practical and theoretical components as well as self-awareness. The training lasts at least 3 years full-time and at least 5 years part-time.
	You must register for admission to the examination. Proof that you have passed the examination is a prerequisite for licensure as a child and adolescent psychotherapist.

Voraussetzungen	<ul> <li>In order to be admitted to the examination for child and adolescent psychotherapists, you must</li> <li>have passed a final examination in psychology at a university or equivalent institution of higher education in Germany, including the subject of clinical psychology, or</li> <li>a final examination in education or social education passed in Germany at a state or state-recognized higher education institution, or</li> <li>completed an equivalent university degree abroad and</li> <li>have completed full-time or part-time training at one of the state-approved training institutes.</li> </ul>
Kosten	Free of charge
Verfahrensablauf	You must register for the state examination as a child and adolescent psychotherapist. To do so, use the form prescribed by the state authority responsible for you. Submit your application with the required documents to the state examination office responsible

Bearbeitungsdauer	However, the candidate should be notified in writing of the admission and the invitation to the examination dates at least two weeks before the start of the examination.
Frist	Following the reform of psychotherapeutic training, training as a child and adolescent psychotherapist can only be completed by September 1, 2032, provided that a course of study qualifying for participation in postgraduate training was started or completed before September 1, 2020. After September 1, 2032, only a license according to the Psychotherapists Act of November 15, 2019 can be obtained. The legal basis does not provide for an explicit application deadline. The competent authorities usually set an application deadline of June 10 for examinations in the fall and January 10 for examinations in the spring.
