Teaser	If you employ trainees as an employer, you must enter their vocational training in the register of vocational training relationships and update or amend it as required.
Volltext	 The register of vocational training relationships is kept by the bodies responsible for training. For example Chamber of Industry and Commerce, Chamber of Crefts
	Chamber of Crafts,other professional chambers.
	It contains all recognized training occupations and records all essential contents of the vocational training contract.
	If there are any changes after registration, you as the training provider can submit an application for a change to the competent regional authority. The competent authority will check the legality of the change and then confirm the change to the vocational training relationship.
	Changes can affect the following areas, for example

Kosten	Gebühr: 0€ - 100€ The change may be subject to a fee for you as a training center. The fee is based on the respective fee regulations of the regional authorities responsible.
Verfahrensablauf	As the training provider, you submit the application for the change to the responsible office in analog or electronic form.
	The competent body will check the relevant data and documents in accordance with the Vocational Training Act and record them in the register of vocational training relationships.
	During the change, the training contract and training plan, for example, can be checked again with regard to the legal requirements, as well as the training center with regard to suitability for training.
	If necessary, the responsible office will contact you for the following reasons:

Ansprechpunkt	 Contact the chamber responsible for your vocational training. This can be the Chamber of Industry and Commerce for vocational training in non-trade occupations, the Chamber of Agriculture for vocational training in agricultural and rural domestic professions the Chamber of Lawyers, Patent Attorneys and Notaries as well as the Notary's Office for the vocational training of specialists in the field of law, the Chamber of Auditors and the Chamber of Tax Consultants for the vocational training of professionals
