Teaser	You would like to know whether there is a suspicion of contaminated sites or harmful soil changes on a property? If so, you can request information from the register of contaminated sites from the relevant authority.
Volltext	Sites suspected of being contaminated are, on the one hand, plots of land of decommissioned companies/plants and other plots of land on which environmentally hazardous substances have been handled (contaminated sites) and, on the other hand, plots of land of decommissioned waste disposal plants and other plots of land on which waste has been treated, stored or deposited (contaminated sites). The competent authority maintains a register of contaminated sites in which areas suspected of being contaminated are registered. For various reasons, a property owner or a person with a legitimate interest needs to know whether a property is suspected of being contaminated. For this purpose, an application for information from the register of contaminated sites can be submitted to the competent authority. For the provision of information to persons who are not themselves the owner of the requested property, a
