Teaser	If you want to open a hatchery or market hatching eggs and/or chicks from domestic poultry, you need to be registered.
Volltext	If you wish to run a business whose activity consists of placing hatching eggs in incubators, incubating these eggs and supplying chicks and hatching eggs, you must apply to the competent authority for registration. The following businesses must be registered: • Hatcheries with a capacity of 1,000 hatching eggs or more • Breeding and multiplication farms with 100 animals or more
