Volltext	Legal entities whose entry in the Commercial Register must be made with regard to the subject matter or the nature and scope of their business operations must be applied for entry by all members of the Management Board. The prerequisite for the obligation to register is the operation of a commercial enterprise. Kosten	The amount of the fee for the registration is determined by the Court and Notary Fees Act in conjunction with the Ordinance on Fees in Commercial, Partnership and Cooperative Register Matters. In addition, expenses are incurred for the public announcement of the registration.
Verfahrensablauf	The application must be submitted to the registry court electronically in a publicly certified form. After successful application you will receive a registration notice.
