You can view information free of charge on the Joint Commercial Register Portal of the German federal states. In addition, you can view free of charge • view the documents submitted • download a printout as a PDF. It is also possible to view the commercial register via the Business Register, which was introduced on 01.01.2007. In addition to the data from the Commercial Register, other information such as annual financial statements of corporations or company
