Teaser	You got married abroad and at least one of you is a German citizen? Then you can have the marriage certified at a registry office in Germany.
Volltext	<ul> <li>If you got married abroad and at least one of you has German citizenship, you can have the marriage certified in Germany.</li> <li>The date of the application is decisive for the possession of German citizenship.</li> <li>The marriage must have been validly concluded in the country in which you got married. German law must not stand in the way of the marriage.</li> <li>You are entitled to apply: <ul> <li>The spouses</li> <li>If both spouses are deceased, their parents and children</li> </ul> </li> </ul>

Erforderliche Unterlagen	<ul> <li>Foreign marriage certificate, if necessary with certification by the competent foreign authority (apostille) or legalization by the German diplomatic mission abroad</li> <li>Valid identity card, passport or travel document</li> <li>Certified copies of the birth registers from the registry offices of the places of birth</li> <li>If the spouses were born in Germany</li> <li>Birth certificates certified by the competent foreign authority (apostille) or legalization by the German diplomatic mission abroad</li> <li>If the spouses were born abroad</li> <li>Translations of all documents in a foreign language by sworn translators in Germany</li> <li>Certificate of naturalization or certificate of citizenship, if applicable</li> <li>Proof of the establishment and dissolution of all civil partnerships</li> <li>Only required if one spouse has already</li> <li>Sectified copy from the marriage register of the last previous marriage with a note of dissolution</li> <li>Only required if one spouse has been married before. Alternatively or in the case of previous marriage abroad: Proof of the conclusion and dissolution of all previous marriages. For example, marriage certificates, death certificates, all divorce decrees - complete and with a note from the court stating when the judgment became legally binding ("final judgment").</li> <li>If applicable, recognition of the foreign divorce by the President of the Higher Regional Court</li> <li>Only required if one spouse has already been married.</li> <li>Further documents</li> </ul>
Voraussetzungen	<ul> <li>You got married abroad and one of you is a German citizen. The date of the application is decisive for the possession of German citizenship.</li> <li>The marriage must be legally valid and must not contradict German law.</li> </ul>

Kurztext	<ul> <li>Marriage abroad Notarization of German marriages or their participation in marriages concluded abroad</li> <li>At least one of the spouses must be a German citizen.</li> <li>The date of the application is decisive for the possession of German citizenship.</li> <li>Responsible: the registry office of the place of residence, the last place of residence or the usual place of residence.</li> <li>If there has never been a place of residence in Germany or if the habitual residence is not in Germany, the registry office I in Berlin is responsible:</li> <li>Registry Office I Schönstedtstraße 5 13357 Berlin</li> </ul>

Zuständige Stelle	<ul> <li>If you are resident in Germany, the registry office of the place where you have or last had your residence or where you have your habitual abode is responsible.</li> <li>Otherwise, the registry office I in Berlin is responsible.</li> </ul>
