| Volltext                   | <p>The creditors' meeting is the highest self-governing body in insolvency proceedings. Important decisions can be made by the creditors at these meetings. For example, the creditors' meeting has the following tasks and rights:</p> <ul style="list-style-type: none"> <li>• Election of another person as insolvency administrator to replace the person who was previously appointed (Section 57 InsO),</li> <li>• Filing an application for the dismissal of the insolvency administrator (Section 59 InsO),</li> <li>• Application for the dismissal of a member of the creditors' committee (Section 70 InsO),</li> <li>• Requesting individual information and reports from the insolvency administrator on the respective state of affairs and management (§ 79 InsO),</li> <li>• Granting maintenance from the insolvency estate to the debtor and his family (§ 100 InsO),</li> <li>• Deciding on the continuation of the proceedings, in particular on the continuation or discontinuation of a company (§ 157 InsO),</li> <li>• Approval of particularly important legal acts of the insolvency administrator (§ 160 InsO),</li> <li>• instructing the insolvency administrator to draw up an insolvency plan (section 218 InsO), or</li> <li>• filing an application for the subsequent ordering or revocation of self-administration (sections 271 et seq. InsO).</li> </ul> <p>The most important stages in insolvency proceedings at which a creditors' meeting is usually convened, unless the proceedings are conducted in writing, are</p> <ul style="list-style-type: none"> <li>• Report meeting</li> <li>• Review meeting</li> </ul> |
