This also applies if the costs of the funeral were paid from public funds. If there is a surplus, the spouse, partner, children, parents, step-parents, foster parents, grandchildren, grandparents, siblings and siblings' children are entitled to receive the benefit in turn if they were living in the same household as the deceased at the time of death.</p> <p>If there are no such beneficiaries, the surplus will not be paid out.</p>

Hinweise	<ul style="list-style-type: none"> • Benefits to be granted on the basis of other statutory provisions (e.g. death benefits from health insurance or civil servants' pensions) are offset against the funeral allowance. • If an injured person dies as a result of an injury outside his/her permanent place of residence, the necessary costs for the repatriation of the body will be reimbursed. This does not apply if the death occurred during a stay abroad. In this case, however, you can apply for assistance.
